Misión Mazahua Advisory Board Meeting

Open prayer for the group was led by Dave McCoy and closed by Dave Hawk.

John & Carol Thomas gave a presentation and video on their trip to Las Rosas. Carol will lead a group down there July 27 – August 3<sup>rd</sup>. Her goal is to take 6 – 12 people with her. There are 11 interested to go now if all goes well. It was decided that Sharon Stoots will get the video and make copies.

Dave Hawk moved to accept the minutes from the October 16, 2004 meeting and Sharon Stoots seconded. Motion carried.

Dave Hawk gave the report for treasurer. 2004 had the highest income that was ever received thru the MMAB. Another thirty thousand went thru the NA and together they were a little over half of the Mission's income. Dave is going to get a checkbook for Lisa & Norberto when he finds a bank that is in Texas and Cleveland. The ledger will have some name changes on some of the funds and be rearranged some. Fund #27 will have sub categories for individuals who go down to the Mission. Jon Stoots moved to accept the report and Sharon Stoots seconded. Motion carried.

Pastor Dan prayed over the food so we could eat and continue to conduct business.

Old Business - Dave McCoy reported that he has secured the domain name of mmab.org. The E-mail address is mmab@wcnnet.org. We can have as many E-mail accounts as we want. Dave McCoy will filter what comes thru. The cost is \$12.00 a year to have others that don't have to be filtered and are separate accounts. It was decided to set up one account thru filters for the listproc so Dave's mail address is not on them. It was decided to use the E-mail address of advisoryboard@mmab.org.

The idea to put the Bible on tape or CD in Mazahua was talked about.

A vision building retreat was talked about. Invite Jack Brown, Steve Shafer and others to come and make a big push to regroup. Try to plan and bring information to the June meeting. It could be held in late September or early October. Dave Hawk will start to look for places and times.

Conference calls or video calls were discussed. This would be a way to get Lisa & Norberto involved with the retreat or meetings if they cannot attend. We need to find out what is available in Mexico.
